## RASSED ISSUES MPS SCORECARDS FOR THE 18<sup>TH</sup> PARLIAMENT

- 75 MPs each submitted less than 10 questions in four years.
- 70% of the parliamentary questions were submitted by 25 MPs.
- 25 MPs provided 60% of the total interventions in the 18th Parliament.
- 51% of the «articulated» interventions were submitted by 14 MPs.
- 75% of the «qualitative» interventions were submitted by 22 MPs.
- 75% of the correct points of order were submitted by 16 MPs.
- A third of the MPs' absences were without excuse.
- 38 MPs each made less than 20 interventions over a period of four years.
- The Palestine, Legal, Financial, Economic, Investment and Administrative Committees are the most active.
- 41 MPs make up 51% of the total absences.

Hayat - RASED has issued the second section of its report on monitoring the performance of the 18th Parliament in the course of four years. Dr Amer Bani Amer, General Director of Hayat-RASED, confirmed that this section of the report sheds light on the performance of MPs for four years, with focus on both oversight and legislative parts, to ensure that a clear picture is presented to the public, the media, the MPs themselves and those interested in parliamentary affairs.

Dr Bani Amer also emphasized that the report is a qualitative analysis and constitutes an integrated study of the effectiveness of the parliament's performance, whether on the oversight or legislative side within the parliament. It also provides a comparative analysis between the individual performance and the overall performance of MPs in the pillars of legislation and oversight and the extent of commitment to attend parliamentary sessions, the performance of parliamentary committees and the enumeration of activities that were held during the four years.

As for the interventions made by MPs during the parliamentary sessions, their number reached 8080, of which 1706 were oversight interventions, which were the interventions made by the MPs during the oversight sessions, while 1444 were the qualitative interventions which are the interventions made by the MPs and were praised by two or more MPs or contained a proposal that did not succeed through voting, and 517 articulated interventions which are the interventions made by the MPs, which included a proposal and a recommendation that was voted on and succeeded.

The results showed that 60% of the parliament's interventions were submitted by 25 MPs over the four years, while 51% of the "articulated" interventions were submitted by 14 MPs, and 75% of the qualitative interventions were submitted by 22 MPs. It should also be noted that the parliamentary sessions were stopped on 3/2020/15/ due to the Covid-19 pandemic until the end of the fourth regular session.

The MPs who submitted the most articulated interventions were: Abd al-Karim al-Daghmi, Wafaa Bani Mustafa, Abdel Moneim al-Awdat, Khalil Atiyah, Salih al-Armouti, Suleiman al-Zabn, Khair Abu Sa`ilik, Reem Abu Dalbough, Aqla Ghammar al-Zaboon, and Dima Tahboub.

In addition, the MPs who submitted the most qualitative interventions were: Saleh Al-Armouti, Abdullah Al-Akayleh, Ahmed Al-Raqb, Wafa Bani Mustafa, Nabil Al-Shishani, Dima Tahboub, Hoda Al-Atoum, Nabil Ghishan, Barakat Al-Nimr Al-Abadi and Khalil Atiyah.

As for the MPs who submitted the most oversight interventions were: Saleh Al-Armouti, Wafa Bani Mustafa, Abdel-Karim Al-Daghmi, Mustafa Yaghi, Musleh Al-Tarawneh, Yahya Al-Saud, Khalil Atiyah, Khaled Ramadan, Muṭtaz Abu Rumman and Fawaz Al-Zoubi.

As for the parliamentary questions submitted by the 18th Parliament, their number reached 2,493 questions which were submitted by 108 MPs. For 75 MPs each submitted less than 10 questions within four years, and 25 MPs submitted 70% of the parliamentary questions. Regarding the points of order, 16 MPs submitted 75% of the total points of order.

The MPs who submitted the most questions were: Muhammad al-Riyati, Ahmad al-Raqb, Khalil Atiyah, Saleh al-Armouti, Sadah al-Habashneh, Dima Tahboub, Ahmad al-Himsat, Hoda al-Atoum, Faisal al-Awar, Nabil Ghishan, Fawaz al-Zuabi, Wafa Bani Mustafa and Khaled Abu Hassan.

The report also showed that the most active and meeting of the parliamentary committees during the four years were: the Palestine, Legal, Finance, Economy and Investment, in addition to the administrative committee.

Regarding the MPs' commitment to attend the sessions, the results showed that 41 MPs made up 51% of the total absences of the Parliament during the four years, while the MPs that were the most present at the sessions were: Ibrahim Al-Badour, Muhammad Al-Falahhat, Salih Al-Armouti, Musa Hantash, Ibrahim Abu Al-Sayed, Mahmoud Al-Naimat, Muntaha Al-Baoul, Khaled Ramadan, Ramadan Al-Haniti, Sadah Al-Habashneh, Ahmed Al-Hemsat and Fadil Al-Nahar Al-Abadi..
